## **Information Collection**

We maintain a record of your information at the offices of Noyes Hall & Allen, so we can service your insurance. The employees of Noyes Hall & Allen are each required to sign and acknowledge a Confidentiality and Nondisclosure Agreement. Each employee has been instructed on maintaining the privacy of each customer and the importance of protecting our clients' personal information.

If you pay your insurance premium with a credit or debit card we delete your account information from our records after your purchase has been authorized. We do not keep a record of your credit card information. If you pay the premium using your personal check, we may keep a copy of your check in your file.

When you send us e-mail from this web site, you will provide us with certain personally identifiable information, including your e-mail address.

## **Cookies**

A cookie is a piece of data that is stored on a visitor's device while they are visiting this web site. Noyes Hall & Allen's web site uses cookies to identify one unique visitor from another during a particular session. A session is the period of active site-use while that unique visitor is linked to our server. We may use cookie technology during a session as a tool to carry forward your information and avoid asking you for repetitive information. No personally identifiable information is stored on the cookie.
